PERMIT AND CONSTRUCTION DRAWINGS

This effort includes the following:

- 2. Prepare floor plans, wall sections, interior and exterior elevations for review and approval
- 3. Construction Documents for use in permitting and construction:
 - a Architectural
 - b. Mechanical engineering for re-designing the ductwork to match the new floor plan
